The Governing Body believes that good behaviour is conducive to good learning and seeks to create an environment in the school which encourages and reinforces good behaviour. Furthermore, it is acknowledged that society expects good behaviour as an important outcome of the educational process. The school's core Christian values of Courage, Forgiveness, Honesty, Love and Respect are central to the school's approach to behaviour management.

- **Courage** - having the courage to deal with difficult situations that we find ourselves in
- **Forgiveness** - graciously accepting an apology from someone and showing forgiveness
- **Honesty** - owning up when we have done something wrong
- **Love** - treating others with love and kindness at all times
- **Respect** - caring for everyone in our school community and beyond and for the environment

Aims

- To create an environment which encourages and reinforces good behaviour
- To promote behaviour for learning, which develops resilience and grit (ASTONishing Learners)
- To define acceptable standards of behaviour
- To encourage consistency of response to both positive and negative behaviour
- To promote self-esteem, self-discipline and positive relationships
- To ensure that the school's expectations and strategies are widely known and understood
- To encourage the involvement of both home and school in the implementation of this policy

BEHAVIOUR FOR LEARNING

The following learning characteristics have been agreed by all children and staff and are embedded in everyday school life:

Aspirational - I dream big

Tenacious - I can't do it YET!

Independent - I am self -motivated

Hardworking - I give my all

Curious - I ask questions

Engaged - I love learning

We believe that these learning characteristics are key to ensuring the educational success of our children. By demonstrating these characteristics, the children will become successful learners and will be able to achieve their full potential.

STANDARDS OF BEHAVIOUR

In seeking to define acceptable standards of behaviour it is acknowledged that these are goals to be worked towards rather than expectations which are either fulfilled or not. The school has a central role in the children's social and moral development just as it does in their academic development. Just as we measure academic achievement in terms of progress and development over time towards academic goals, so we measure standards of behaviour in terms of the children's developing ability to conform to our behavioural goals.

The children bring to school a wide variety of behaviour patterns based on differences in home values,

attitudes and parenting skills. At school, we must work towards standards of behaviour based on the basic principles of honesty, respect, consideration and responsibility. It follows that acceptable standards of behaviour are those which reflect these principles.

SCHOOL ETHOS

The adults encountered by the children at school have an important responsibility to model high standards of behaviour, both in their dealings with the children and with each other, as their example has an important influence on the children.

As adults we should aim to:

- create a positive climate with realistic expectations
- emphasise the importance of being valued as an individual within the group
- promote, through example, honesty and courtesy
- provide a caring and effective learning environment
- encourage relationships based on kindness, respect and understanding of the needs of others
- ensure fair treatment for all regardless of age, gender, race, ability and disability
- show appreciation of the efforts and contribution of all
- use whole school rewards, e.g. Dojos to praise precisely according to our core Christian values and ASTONishing Learner characteristics.

THE CURRICULUM AND LEARNING

We believe that an appropriately structured curriculum and effective learning contribute to good behaviour. Thorough planning for the needs of individual pupils, the active involvement of pupils in their own learning, and structured feed-back all help to avoid the alienation and disaffection which can lie at the root of poor behaviour.

It follows that lessons should have clear objectives, understood by the children, and differentiated to meet the needs of children of different abilities. Marking and record keeping can be used both as a supportive activity, providing feed-back to the children on their progress and achievements, and as a signal that the children's efforts are valued and that progress matters.

We encourage children to learn from their mistakes and to take this as a positive step towards progress. We believe that developing a child's resilience to overcoming difficulties is a crucial life skill and should be nurtured from the start.

CLASSROOM MANAGEMENT

Classroom management and teaching methods have an important influence on children's behaviour. The classroom environment gives clear messages to the children about the extent to which they and their efforts are valued. Relationships between teacher and children, strategies for encouraging good behaviour, arrangements of furniture, access to resources and classroom displays all have a bearing on the way children behave.

Classrooms should be organised to develop independence and personal initiative. Furniture should be arranged to provide an environment conducive to on-task behaviour. Materials and resources should be arranged to aid accessibility and reduce uncertainty and disruption. Displays should help develop self-esteem through demonstrating the value of every individual's contribution, and overall the classroom should provide a welcoming environment. In addition, working walls and learning prompts should be used to support independence in learning.

Teaching methods should encourage enthusiasm and active participation for all. Lessons should aim to develop the skills, knowledge and understanding which will enable the children to work and play in co-operation with others. Precise praise should be used to encourage good behaviour as well as demonstrating effort.

RULES AND PROCEDURES

Rules and procedures should be designed to make clear to the children how they can achieve acceptable standards of behaviour.

Rules and procedures should:

- be kept to a necessary minimum
- be positively stated, telling the children what to do rather than what not to do
- actively encourage everyone involved to take part in their development
- have a clear rationale, made explicit to all-e.g. 'The Handful of Rules'
- be consistently applied and enforced-e.g. Stop signal, transitions 1, 2, 3
- promote the idea that every member of the school has responsibilities towards the whole

REWARDS

Our emphasis is on rewards to reinforce good behaviour, rather than on failures. We believe that rewards have a motivational role, helping children to see that good behaviour is valued. The commonest reward is praise, informal and formal, public and private, to individuals and groups. It is earned by the maintenance of good standards as well as by particularly noteworthy achievements. This is as true for adults as for children. Rewards can be stickers, Dojos and nominations for Headteacher's Awards. Each Celebration Assembly will recognise two children from each class who demonstrate good behaviours linked to our core Christian values and ASTONishing Learner characteristics.

HANDFUL OF RULES

The Handful of Rules, which is formulated in consultation with the children, will be revisited at the beginning of each term. This will cover appropriate behaviour around the school, at play and lunchtimes as well as in the classroom. Frequent referral to the Handful of Rules should be made when discussing expectations, and when a child has transgressed it is a powerful tool to ask them to identify which part of the Handful of Rules they have broken. The handful of rules is based upon our 5 core values.

SANCTIONS

Although rewards are central to the encouragement of good behaviour, realistically there is a need for sanctions to register the disapproval of unacceptable behaviour and to protect the security and stability of the school community. In an environment where respect is central, loss of respect, or disapproval, is a powerful deterrent.

The use of punishment should be characterised by certain features:

- it must be clear why the sanction is being applied
- it must be made clear what changes in behaviour are required to avoid future punishment
- group sanctions should be avoided as they breed resentment
- there should be a clear distinction between minor and major offences
- adult support will help the child to identify inappropriate behaviour and how to move forward

Sanctions range from expressions of disapproval (non-verbal and verbal), through to withdrawal of privileges including part or whole of playtimes and/or lunchtimes, being put on report, to referral to the Headteacher, letters to parents and, ultimately and in the last resort, exclusion (following the LEA guidelines).

Where anti-social, disruptive or aggressive behaviour is frequent, sanctions alone are ineffective. In such cases careful evaluation of the curriculum on offer, classroom organisation and management, and

whole school procedures should take place to eliminate these as contributory factors. Additional specialist help and advice from the Educational Psychologist or the Behaviour Support Team may be necessary. This possibility should be discussed with the SENCo and Headteacher. Nurture support can also be provided.

Exclusions:

Violent or abusive behaviour directed at another pupil or a member of staff or persistent disruptive behaviour will result in a fixed-term exclusion unless agreed individual behaviour plans specify otherwise. For younger children, violent behaviour will at first result in internal exclusions (where the pupil completes work away from other learners); after three occasions this will trigger a fixed-term exclusion. In this instance, parents will be informed as soon as possible, giving reasons for the exclusion. Parents will be given information about their right to appeal against the decision to the governing body. If circumstances are extreme, pupils can also be excluded permanently. If fixed-term or permanent exclusions are deemed necessary, the school will follow the DfE guidance.

USE OF REASONABLE FORCE

What is reasonable force?

- The term 'reasonable force' covers the broad range of actions used by most teachers at some point in their career that involve a degree of physical contact with pupils.
- Force is usually used either to control or restrain. This can range from guiding a pupil to safety by the arm through to more extreme circumstances such as breaking up a fight or where a child needs to be restrained to prevent violence or injury.
- 'Reasonable in the circumstances' means using no more force than is needed.
- As mentioned above, schools generally use force to control pupils and to restrain them. Control means either passive physical contact, such as standing between pupils or blocking a pupil's path, or active physical contact such as leading a pupil by the arm out of a classroom.
- Restraint means to hold back physically or to bring a pupil under control. It is typically used in more extreme circumstances, for example when two pupils are fighting and refuse to separate without physical intervention.
- School staff should always try to avoid acting in a way that might cause injury, but in extreme cases it may not always be possible to avoid injuring the pupil

Who can use reasonable force?

- All members of school staff have a legal power to use reasonable force¹.
- This power applies to any member of staff at the school. It can also apply to people whom the headteacher has temporarily put in charge of pupils such as unpaid volunteers or parents accompanying pupils on a school organised visit.

When can reasonable force be used?

- Reasonable force can be used to prevent pupils from hurting themselves or others, from damaging property, or from causing disorder

- In a school, force is used for two main purposes - to control pupils or to restrain them
- The decision on whether or not to physically intervene is down to the professional judgement of the staff member concerned and should always depend on the individual circumstances.

The following list is not exhaustive but provides some examples of situations where reasonable force can and cannot be used.

Schools can use reasonable force to:

- remove disruptive children from the classroom where they have refused to follow an instruction to do so
- prevent a pupil behaving in a way that disrupts a school event or a school trip or visit
- prevent a pupil leaving the classroom where allowing the pupil to leave would risk their safety or lead to behaviour that disrupts the behaviour of others
- prevent a pupil from attacking a member of staff or another pupil, or to stop a fight in the playground
- restrain a pupil at risk of harming themselves through physical outbursts.

Schools cannot:

- use force as a punishment - it is always unlawful to use force as a punishment.

Communication and parental partnership

We give high priority to clear communication within the school and to a positive partnership with parents since these are crucial in promoting and maintaining high standards of behaviour.

Where the behaviour of a child is giving cause for concern it is important that all those working with the child in school are aware of those concerns, and of the steps which are being taken in response. The key professional in this process of communication is the class teacher who has the initial responsibility for the child's welfare. Early warning of concerns should be communicated to the Headteacher so that strategies can be discussed and agreed before more formal steps are required. If there has been a serious incident necessitating the use of force, the parents of the child will be contacted by the headteacher.

A positive partnership with parents is crucial to building trust and developing a common approach to behaviour expectations and strategies for dealing with problems. Parental participation in many aspects of school life is encouraged. This participation assists the development of positive relationships in which parents are more likely to be responsive if the school requires their support in dealing with difficult issues of unacceptable behaviour.

The Behaviour Policy is given to new parents as part of the admissions pack and is also available via the website. Where behaviour is causing concern, parents will be informed at an early stage, and given an opportunity to discuss the situation. Parental support will be sought in devising a plan of action within this policy, and further disciplinary action will be discussed with the parents.
